Each month you will receive an invoice from NNMIEC showing a line for your monthly assessment which is calculated, on private work, at \$.21 per hour for each productive electrical worker (Journeyman, Apprentice or Foreman). On Public Works jobs the hourly assessment is calculated at the pre-determined amount for apprenticeship. Invoices will show a zero-amount due for assessments because **you** must determine each month's assessment based on your total hours worked for that respective month.
